Warm Greetings!

At the outset, we at Sri Chaitanya, extend our gratitude to all the parents for the continuous support and co-operation extended to us in adopting the changes in the learning experiences, due to the pandemic.

We are glad to inform you that Physical Schooling for Senior Secondary students of Grade 9 and Grade 10 will commence from 2nd September 2021, (Thursday), as per the guidelines issued by the Karnataka Government.

The odd-even pattern of Roll numbers will be followed.

Timings - 8.40am to 1.20pm.

Instructions and Guidelines:

- ❖ The SOPs issued towards conducting the classes in the school premises and our system are as per norms.
- ❖ The school will be implementing all the necessary health and safety measures, as per the guidelines issued by the Karnataka Govt. (Temperature Screening, Wearing of Mask, Social Distancing norms etc.)
- ❖ The Teaching and Non-teaching Staff are all vaccinated and their Certificates are maintained in the office.
- ❖ School is being cleaned and sanitized regularly, on daily basis.
- ❖ **Parents, of the students who are attending physical school, should have been vaccinated.**
- ❖ The **Consent Form** that has been sent should be duly filled and submitted to the school, on the first day itself, along with the Xerox copy of the Parents' Vaccination Certificates, based upon which, the student would be allowed for Physical Classes.
- ❖ Students travelling to school by Private vehicles need to ensure that the driver is vaccinated.
- ❖ Students should follow the norms of being in appropriate hair style and wearing only school uniform.
- ❖ Students should deposit their mobile phone (if any) in the office before commencement of classes, failing which, strict action would be taken.
- ❖ It is mandatory to adopt **COVID APPROPRIATE BEHAVIOUR.**
- ❖ Students have to strictly follow the **COVID NORMS** like **wearing face shield, gloves and mask, using own sanitizers and maintaining social distancing.**
- ❖ Water bottle and food/snacks should be carried from home. Very importantly, **food should not be shared.** Exchange of stationery is not allowed.
- ❖ Currently, school transportation is not available. Based on the requisition of the parents, the management will take the decision after 15 days.
- ❖ **Kindly install Aarogya Setu App to track potential risk of Covid-19 affected people around you and get notified for any risk history found near you.**
- ❖ Parents must ensure that the students are not visiting any crowded places after school hours.
- ❖ Requesting parents and students to avoid travelling unnecessarily, till the situation returns back to normal.
- ❖ Kindly refrain from sending the student to school if any health symptoms are noticed within the family or if you have not completed the quarantine period according to Government Rules (due to health issues/interstate travel etc.).
- ❖ Vaccinated Parents can meet the Staff or Principal **only on prior appointment** through Office
