Under the above circumstance, the Karnataka Fire & Emergency Services Department is issuing Fire Safety Recommendation to "Sri Chaitanya Techno School, a constructed school building at #86/1c, Opposite S.G.R Dental College, Munnekolala, Marathahalli, Bangalore-560037" subject to condition and compliance of the above recommendations in Column-4 of serial-B within 3 months and compliance from the undersigned.
