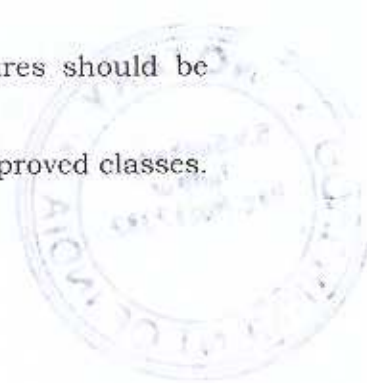

CONDITIONS:

1. This registry is subject to rule 3 [5] [4].
2. The governing council must comply with all the conditions stated by Rule 4[4].
3. Subject to conditions such as provision of school premises, area building furniture, staff class financial benefits etc., the educational institution cannot in any case open more sections without the government's prior permission.
4. The school shall be opened only in the sanctioned medium and in the same place and shall not be changed for any reason. The governing body shall be in the same place and the same name.
5. The Karnataka Education Bill 1983 [Karnataka Act No:1:96] shall comply with all government orders and regulations issued by and regularly issued to the institutions of education. The statutes and rules created under this shall be adhered.
6. As per the proposal of the government, under Karnataka Act No: ED:175 PMC:95, Dated 07-09-1998 and Dated 29-12-1998. The grant of this certified consent before the notary in the rupee of 10/- clause does not require any grant from the government.
7. That under this Karnataka Private Educational Institutions (Recruitment, Service and Regulation of Employees of Private Aided Primary and Secondary Education Institutions) under Rule1999.

8. Departmental and government-mandated textbook testing procedures should be adopted only.

9. There should be minimum 25 strength of attendance in each of the approved classes.



10. Only trained and qualified teachers shall be appointed as per the rules and regulations of the Karnataka Education Bill, under order 8 which is subject to the recognition and provisional validity of all schools registered under subsection 36-39 of the Karnataka Education Bill.

11. Students Medical examination must be done every year.

12. In order to start the school, the institution should keep the security deposit in the joint account of the District Deputy Director and the Governing Body.

13. According to the Karnataka Education Bill rules, all the necessary facilities such as branch furniture, furniture, library books, playground and school building should be abolished within a year. If not, the registration will be canceled.

14. The office should be informed of the school's openness and the student's enrollment information within three months of the school's enrollment or the beginning of the academic year. This order is automatically canceled if the school does not open and does not meet any conditions.

15. A separate toilet system for girls and boys at school should be provided and clean drinking water.

16. Submission to the Deputy Director for First Accreditation. The Deputy Director shall issue a mandatory first accreditation within three months of commencement of school on the basis of the Education Act and the Government Order Date 30-09-2007 Appendix Checklist.

17. Ensuring that school building safety is safe from fire hazards such as a firestorm or electrical accident and also it should be between 100 meters away by selling tobacco selling products also mention the name board in front of the school.

18. The department reserves the right to cancel registration if the school board gives any wrong information.

19. The Government notification No: ED 369 PGC2014, Dated:11-11-2014 should ensure that the office has complied with the terms and conditions dated 14-11-2014.

20. Government notification ED No:709 PGC 2017 dated 07-03-2018 conditions must be followed under dated 26-03-2018 and to confirmed the same.
