- that the Institution shall adopt the curriculum and syllabus prescribed from time to time.
- that the school timings, vacations and mid terms holidays shall be as prescribed by the Government from time to time.
- that the qualified staff within the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.
- 6 that the results of institution shall be satisfactory every year.
- 7 that the records/accounts shall be furnished to the district Educational officer or nominee every year at the time of instruction.
- that the list of governing body shall be furnished to the District Educational Officer/competent authority every year.
- that the pay structure/fee structure fixed by the Governing body shall got approved by the District Educational Officer or nominee every year.
- that all the conditions prescribed in the G.Os. and other orders which are not specified in this order shall be complied with. Otherwise the Provisional Recognition will be cancelled.

that the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least 6 months before.

that the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.

that the society shall submit proposals for Provisional Recognition sufficiently in advance as per G.O.Ms.No.1, Edn., dated:1-1-94.

The above Provisional Recognition is subject to a written undertaking being given by the school Management that the recognition purely on temporary basis and is subject to the reports of State Level Inspection and Vigilance committee fulfilling of all the Pre-perquisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfill any prerequisite as stipulated, the Provisional Recognition now being is liable to be withdrawn at once.
