The District Educational Officer, Nellore has verified the application for grant of Provisional Recognition for classes I to VII English Medium for the academic year 2020-2021 to 2029-2030 for a period of 10 years (without aid) With reference to the report of the Mandal Educational officer, Kavali and also with reference to the conditions laid down in the G.O.Ms.No.1, Edn., dated 1-1-1994.

After careful examination of the references cited and conditions prescribed in G.O.Ms.No.1, Edn., dated: 1-1-1994 the District Educational Officer, Nellore hereby accorded Provisional Recognition for classes I to VII English Medium for the academic year 2020-2021 to 2029-2030 for a period of 10 years (without aid) in respect of Sri Chaitanya English Medium School, Santhi Nagar, Kavali (M) of SPSR Nellore District with the following conditions. However, by the end of April every year the Educational agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1	that the society shall abide by the Instructions/rules regulations made by the Government or authorized officer from time to time.
2	that the educational Institution shall serve the needs of the locality more particularly.
3	that the Institution shall adopt the curriculum and syllabus prescribed from time to time.
4	that the school timings, vacations and mid terms holidays shall be as prescribed by the Government from time to time.
5	that the qualified staff within the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern.
6	that the results of institution shall be satisfactory every year.
7	that the records/accounts shall be furnished to the district Educational officer or nominee every year at the time of instruction.
8	that the list of governing body shall be furnished to the District Educational Officer/competent authority every year.
9	that the pay structure/fee structure fixed by the Governing body shall got approved by the District Educational Officer or nominee every year.
10	that all the conditions prescribed in the G.Os. and other orders which are not specified in this order shall be complied with. Otherwise the Provisional Recognition will be cancelled.

11	that the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least 6 months before.
12	that the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13	that the society shall submit proposals for Provisional Recognition sufficiently in advance as per G.O.Ms.No.1, Edn., dated:1-1-94.
14	The above Provisional Recognition is subject to a written undertaking being given by the school Management that the recognition purely on temporary basis and is subject to the reports of State Level Inspection and Vigilance committee fulfilling of all the Pre-perquisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfill any prerequisite as stipulated, the Provisional Recognition now being is liable to be withdrawn at once.
15	The Management of the school should follow the Provisions of RTE Act without fail.
16	The Management of the School is instructed to pledge the Endowment in the name of the District Educational Officer, SPSR Nellore District.
17	The management is requested to follow the instructions of the Fire Department and renewal the fire certificate from time to time without fail and submit the same to this office.

- 4.The school timings, vacation and mid-term holidays shall be as prescribed by the Government from time to time.
- 5.That the qualified staff with in the age limits prescribed by Govt., for Govt., Employees shall be appointed as per the Staff pattern.
- 6.That the results of the Institutions shall be satisfactory every year.
- 7.That the records /accounts shall be furnished to the D.E.O every year.
- 8.That the list of Governing body shall be furnished to the D.E.O. every year.
- 9.That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
- 10.That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.
- 11.That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
- 12.That the school shall be closed or permitted to closed only from the date on which summer vacation is declared.
- 13.That the society shall submit proposal for renewal of Extension of Temporary Recognition sufficiently in advance i.e., at least 6 months prior to the date of Expiry of the renewal.
- 14.The Recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
- 15.The Management is requested to follow the instructions of the Fire Department and renewal the Fire Certificate from time to time without fail and submit the same to this office through the Deputy Educational Officer, Kavali, and District Educational Officer, SPSR Nellore District.

16.The Management is requested to renewal the Vehicle Fitness Certificate every year from the concerned authorities without fail and submits the same to the concerned Deputy Educational Officer.

Further, the managing committee of the school is requested to fulfill all requirements to cope up with the needs of the institution at the latest before submission of application for extension of Temporary Recognition for the year 2024-2025.
