

3. The School shall admit in Class I (or in pre-school class, as the case may be), to the extent of 25% of the strength of the class, children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion.
4. For the children referred to in paragraph 3, the School shall be reimbursed in accordance with the provisions of sub-section (2) of section 12 of the Act. To receive

such reimbursement school shall maintain a separate bank account.

5. The Society/School shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
6. The School shall not deny admission to any child for lack of age of proof, religion, caste or race, birth place or due to any of the reasons out of this.
7. (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
- (ii) No child shall be subjected to physical punishment or mental harassment;
- (iii) No child is required to pass any board examination till the completion of elementary education;
- (iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23;
- (v) Inclusion of Students with disabilities/special needs as per provision of the Act;

- (vi) The teachers are recruited with minimum qualifications as laid under section 23 (1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;
- (vii) The teacher performs its duties specified under section 24 (1) of the Act; and
- (viii) The school shall ensure that, teachers shall not engage himself or herself for private teaching activities. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.


