

iv) The teachers are recruited with minimum qualifications as laid under section 23 (1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications with in a period of 5 years;

v) The teacher performs his/her duties specified under section 24 (1) of the Act and

vi) The teachers shall not engage himself in private teaching activities.

- vii) That the management of school shall enroll students proportionate to the facilities available in the school as prescribed in section 19 of the Act.
- viii) that the management of school shall maintain the standards and norms of the school as specified in section 19 of the Act.
- 33. No un-recognized class shall run within the premises of the school or outside in the same name of school.
- 34. That the school buildings or other structures or the grounds are not used during the day or night for commercial or residential purposes (except for the purpose of residence of any employee of the school) opr for political or non-educational activity of any kind whatsoever

35. That the school is run by a society registered under the Societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force;

36. That the school is not run for profit to any individual, group or association of individuals or any other persons;

37. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements of Accounts should be sent to the District Educational Officer every year.

38. The permission Code Number allotted to your school is 28/A5/2023. This may please be quoted for any correspondence with this office in future.

39. The school furnishes such reports and information as may be required by the by the Samagra Shiksha/ District Educational Officer from time to time and complies with such instructions of the State Government/Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.

40. The permission shall be withdrawn if the contravention of the provisions of the Act. The Rules and conditions of recognition is found and proved.
