Previously Renewal of Recognition was granted for classes VI to X under English Medium during the year from 2014-2015 to 2017-2018 in respect of Sri Chaitanya High School (EM), D.No.89-17-21/1, Morampudi, Rajamahendravaram, East Godavari District vide Proceedings Rc.No.3004/B4/2014 Dated 29.09.2014 of the Regional Joint Director of School Education, Kakinada.

The Correspondent has submitted the application for **Renewal of Recognition** to the classes VI-X (EM) in the school for the years from 2018-2019 to 2027-2028 in the reference 6<sup>th</sup> cited through the Inspecting Authority. The District Educational Officer, East Godavari, Kakinada District has verified the application for **Renewal of Recognition** with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, is the competent authority for Secondary Schools hereby grants **Renewal of Recognition** for a period of 10 (TEN) years i.e., for the academic year 2018-2019 to 2027-2028 for the classes VI-X (EM) in Sri Chaitanya High School (EM), D.No.89-17-21/1, Morampudi, Rajamahendravaram, East Godavari District under Sri Chaitanya Educational Trust, Hyderabad (Regd.No.284/2007) without Grant In Aid now or in future and subject to fulfillment of the following conditions.

1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized officer from the time to time.
2. That the Educational Institutions shall serve the needs of the locality more particularly.
3. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September

- at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
  9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
  10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
  11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
  12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
  13. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
  14. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
  15. The management informed that no thatched roof accommodation is allowed to run the School.
  16. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students.
  17. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
  18. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
  19. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
  20. The school shall have first aid kit and the teachers shall be trained in first aid.
  21. The Correspondent of the concerned school is hereby informed to file an affidavit by 30<sup>th</sup> April of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
  22. That the Management of the school is informed to obtain the Structural Soundness Certificate and Sanitary Certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
  23. That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
  24. That the management has to maintain trained teachers at all time.
  25. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated 06.08.2009 regarding Fee Structure in Private Schools.
  26. That the Management of the school is informed to obtain the Occupancy Clearance from the Fire Services Department concerned for the complete period of recognition now accorded without fail as the present Occupancy Clearance in the Fire NOC.

If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed.

Receipt of these proceedings should be acknowledged.
