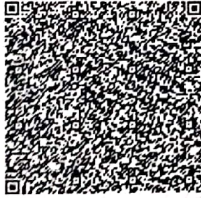

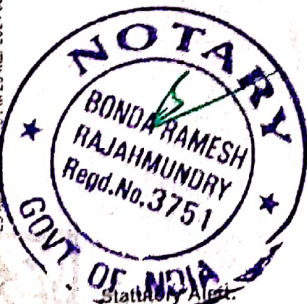


3. That the school is being run as community service and not as a business and that communalization does not take place in the school in any manner what so ever.

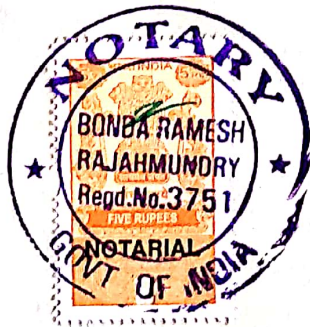
