CODE OF CONDUCT / INSTRUCTIONS

- 01) Applications which are incomplete in this form or those that do not have relevant certificates enclosed will be rejected.
- 02) The School reserves the right to cancel the admission of the Student at any stage, as and when it is detected that the admission is made against the rules.
- 03) A student is deemed to have been admitted into the class / course only after he/she has paid the fee in full.
- 04) At the time of admission, the Parent and the Student are required to sign the declaration that they will abide by the rules and regulations of the School.
- 05) Keep the application intact and do not detach any sheet.
- 06) It is suggested that if the Student / Parent wishes to give any other information like health details, achievements and any other details, they may use a separate sheet of paper.
- 07) The admission of the Student can be cancelled at any time of the year if the School decides that his/her continuance is not in the interest of academics, affecting the progress of co-students or is detrimental to the image of the institution.
- 08) The School Management reserves the right to change, at any time, any of the rules and regulations that pertain to the admission and withdrawal of Students.
- 09) Punctuality should be the prime concern of all Students. They should not abscond or be absent from School without prior permission. Students, without the required percentage of attendance, are not eligible for promotion.
- 10) Students should attend special classes, exams / tests, assessments without fail. No re-exam will be conducted.
- 11) Students should produce the Diary to the Class teacher / coordinator with the Parent's signature after availing the leave period. Leave availed for 3 or more days will be granted only on producing a Medical certificate from a Registered Medical Practitioner.
- 12) Mutilation / spoilage of fixtures / furniture is viewed very seriously. Cleanliness of the classroom/campus is the responsibility of every student.
- 13) Students should be spruce, neat and be mindful of their etiquette at School. Discipline is of prime concern.
- 14) Students are prohibited from bringing valuables in the form of gold ornaments, money purses, mobiles & cameras etc. to the school. The institution will not be responsible for any loss.
- 15) Parents / Guardians are restricted from entering the classrooms / labs / library etc. during School hours. They shall in no way hinder the curriculum of the School or of the child.
- 16) Students suffering from ailments of any kind like Measles, Mumps, Typhoid etc. should bring to the notice of the authority for necessary action and guidance.
- 17) No Student shall leave the campus during the class hours without permission.
- 18) Re-Examinations / Tests are not held during the year for any Student under any circumstance.
- 19) Evening preparatory / study classes that are conducted beyond Goyt, prescribed School timings are organized in the best interest of the Student's academic progress, if any. If the Student does not wish to attend these classes, the Parent should intimate the Principal in writing.
- 20) [Admission + Tuition Fee] minimum 20,000/- non refundable.
- 21) Incomplete applications are liable for rejection with no further intimation.
- 22) Internal transfer from present branch to any other existing branch will be approved after review and Parent has to pay any difference in fee, expense etc. that may arise. Internal Transfer will be strictly allowed only once a year.
- 23) Medium of Instruction will be in English only.
- 24) Transport Charges non refundable, Transportation conformation only after payment.
