1. That SREE MURAGAN EDUCATIONAL TRUST is a registered Trust under the Indian Trust

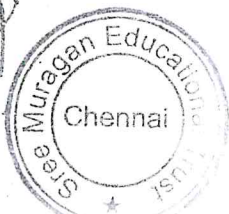

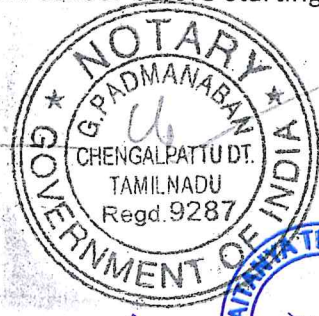

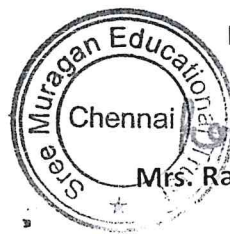
