

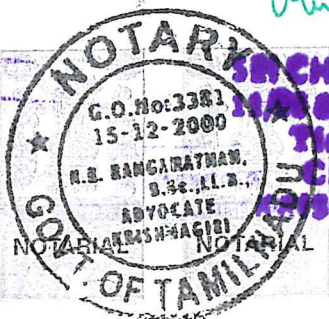

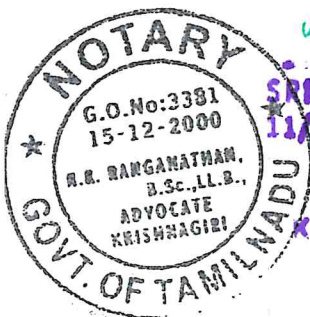
8. That the school will ensure compliance of all statutory requirements like EPF, ESland Labour Laws etc. With respect to the school and staff of the school.
