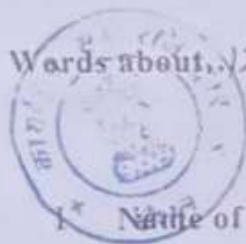

OPENING A BANK ACCOUNT


