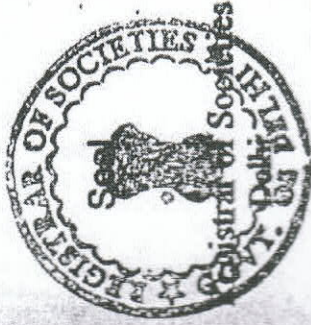

1. NAME OF THE SOCIETY:

3. AREA OF OPERATION:

The Society shall operate its all activities within the territories of India.

4. AIMS & OBJECTIVES:

1. To carry out medical research by engaging in the research and development of all fields of medical sciences and all therapies of medical treatment, so as to provide medical relief in a better way.
2. To provide, encourage, initiate or promote facilities for the discovery, improvement or development of new methods of diagnosis, understanding, prevention and treatment of diseases.
3. To promote spiritual, physical, mental, educational development and upliftment of adults and children of all ages without any distinction of caste, creed or religion and in the interest of mankind in general.

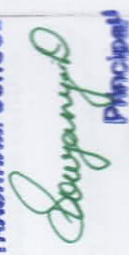

4. To aid and/or establish, takeover or collaboration with any institution or school or association for physical, mental, spiritual and educational development.
5. To educate and create general awareness among the people about communicable diseases particularly S. T. D. e.g. AIDS, Leprosy etc. and/or all other diseases.
6. To propagate, impart and adopt any audio-visual methods for solving the problems of crime, drug abuses and help in the inculcation of such behaviour as would bring happiness to the family of man or generally mankind without reservation of his status, caste and religion.
7. To aid or establish any institution or adopt any other means for imparting, promotion of any art, science or any other field of education, propagate for removal of social evils, customs or render or promote self-help to overcome any of these evils particularly for the poor or weaker section of the society in India or abroad. 8. To establish any home, institution or society for the welfare of victims of natural calamities and/or provide food and shelter to any needy person / persons from time to time.
9. To protect the environmental degradation and maintain ecological balances.

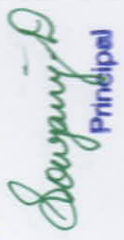

10. To maintain and develop parks, gardens etc. to reduce the pollution level of the surrounding area.
11. To strive for equality of opportunity for the women in the fields of education, training, employment and their socio-economic upliftment.
12. To impart learning among women and deprived children in slum areas by establishing academic institutions from Secondary up to Higher Studies, vocational centers along with adequate facilities for accommodation in collaboration by sponsorship.
13. To educate/guide the women and deprived children in slum areas regarding policies, programmer/scheme of the Govt. regarding their welfare.
14. To promote public consciousness and to disseminate information in Public at large regarding the potential of the women and deprived children in slum areas as professionals, educationists and technocrats etc.
15. To acquire, sale, mortgage or dispose off in any manner, such property as may be considered necessary or expedient for the efficient functioning of the society.
16. The society shall be for the promotion of socio-cultural, economic and educational upliftment.

17. To open orphanages for the old and infirm persons, mentally retarded, blind and handicapped children and persons.
18. To fight against any discrimination, harassments, ill-treatment, untouchables, exploitation and injustices to backward classes of the society.
19. To launch and sustained campaigns for the relief of people, affected by disasters such as famine, drought, floods, cyclone, earthquake, pestilence or epidemics etc.
20. To collect and disseminate information regarding employment opportunities at National and International level, and help the unemployed poor youths for getting job.
21. To help the physically challenged women by establishing marriage bureau in respect of their marriage.
22. To work for the development of harmonious relation between all citizens irrespective of caste, creed, sex or religion.
23. To work for the welfare of schedule castes, schedule tribes and other backward classes.
24. To establish primary health centers, dispensaries and family welfare centers in villages and urban slums.

25. To conduct social and cultural program for the slum and street children and old aged people and to distribute food, medicine, clothes etc which are collected from various sources.

26. To construct and get constructed houses for the poor people and establish ashrams for general public.

27. To educate the people about various family planning methods and benefits associated with it.

28. To act as transmission belt and conduct for widespread, effective dissemination of the Sulabh technology.

29. To organize free medical camps, blood donations camps and eye donation camps in various places and provide assistance to disabled persons for purchase/fitment of aids/appliances.

30. To approach with the authority concerned to provide compensation for men/women in case of accidents and other un-natural mis-happening.

31. To establish Anganwari for providing in village development programs in various places.

32. To publish books on educational and social subjects, organize discussions and seminars to promote knowledge and understanding amongst the people.

33. To publish charts, illustrations, journals, magazines, periodicals and other publications for the propagation of aims and objects of the society.

34. To help the physically challenged men and women in respect of employment by establishing small scale industries through Central and State Govt. aid and other sources of funds.

35. To arrange loans from Government's Financial Institutions, International Organizations with similar aims and objects for overall development and independence of the women and deprived children in slum areas.

36. To raise funds by subscription, donations, grant in-aid, bequests or in any other form that the society considers appropriate provided that such methods of raising funds do not contravene any provision of the law.

37. The investment of the funds of the society shall be made as per the provisions of the Section 11(5) of the Income Tax Act, 1961 and other law of land applicable from time to time.

38. To organize sports, clubs, sports meet, sports competitions to promote sports spirit among the youth.

39. To arrange, organize, run and establish the vocational training center or music, dance, typing, shorthand, computer, painting, sewing, embroidery, dress designing, beautician etc. for the promotion, development and advancement of aims and objectives of the society.

40. To do any other act or thing, which is ancillary to the achievement of any of the above, stated objects.

All the incomes, earnings, movable, immovable properties of the society shall be solely utilized and applied towards the promotion of its aims and objectives only as set forth in the Memorandum of Society and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus, profit or in any manner whatsoever, to the present or past members of the society or to any person claiming through any one or more of the present or the past members. No members of the society shall have any personal claim on any movable or immovable properties of the society or make any profit whatsoever by virtue of his membership.

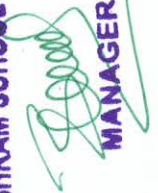
